

INTRODUCTION

Arends, Leslie Cornelius (1895 - 1985), Collection, 1930-75

The Leslie C. Arends collection consists of three major types of material: audiovisual items, papers, and photographs. The papers span Arends' career as United States representative from the 17th congressional district in Illinois. First elected to the House of Representatives in 1935, Arends held the office of Republican assistant floor leader for thirty-one years of his career, from 1943 until 1975.

Upon retirement, Arends donated his papers to Illinois Wesleyan University, in Bloomington, Illinois. The university made arrangements with The Everett McKinley Dirksen Congressional Leadership Research Center to arrange, process, and describe the collection. The papers and finding aids were then returned to Illinois Wesleyan.

The following ten record groups constitute the Arends collection: audiovisual, departments, general, legislation, photographs, positions, post office, publications, speeches, and White House press releases.

Arends periodically disposed of some files. As a result, inclusive dates, amounts of material, and significance of the papers vary within each record group. Series descriptions for the record groups further describe methods of arrangement, amounts and types of material, and inclusive dates. Finding aids are available at the Illinois Wesleyan University Library and at The Dirksen Center, Pekin, Illinois.

BIOGRAPHY

Leslie Cornelius Arends
(1895 - 1985)

Leslie Cornelius Arends was born on September 27, 1895 in Melvin, Illinois, where he, his four brothers, and two sisters grew up on his father's farm. After graduating from Melvin high school in 1912, he attended Oberlin College in Ohio for two years. Arends enlisted in the Navy during World War I, and following his discharge in 1919, returned to Melvin to work in the grain business and private bank founded by his father. In 1946 he married the former Betty Tychon. They have one daughter, Letty.

In his first bid for public office in 1934, Arends ran on the Republican ticket and was elected to serve as representative of the 17th congressional district. The voters returned Arends to the House in the next nineteen elections. In 1974 he announced his retirement and did not seek re-election.

As a congressman, Arends was particularly concerned with reduction of the federal budget and decentralization of the government. As a long-time member of the Military Affairs Committee (now the Armed Services Committee), Arends also expressed special interest in military spending and military preparedness.

In 1943 Arends' fellow party members elected him to the position of minority whip. The whip's major duties are to gauge the feelings of fellow representatives, try to predict their votes on upcoming legislation, and then see that colleagues are present to vote on important legislation. The whip thus aids the party leadership in designing its legislative strategy.

Arends continued to serve as Republican assistant floor leader for thirty-one years. When he announced his retirement in 1974, Arends had served as whip longer than anyone else, Republican or Democrat.

SCOPE AND CONTENT

The Leslie C. Arends (1895 - 1985) Collection, 1930-75, documents his career as a United States representative from Illinois' 17th congressional district and as Republican assistant floor leader in the House of Representatives from 1943 until his retirement in January 1975. The material is divided into ten record groups described separately in a finding aid.

The bulk of the material consists of correspondence with constituents and colleagues, notes, news clippings, pamphlets and reference material, and press releases. Individual record groups also contain audiovisual materials, photographs, publications, and speeches. Inclusive dates for the collection are 1930-75, with the bulk of the material dating from 1950-74. Like many other congressmen, Arends periodically discarded files, which accounts for the uneven quality of remaining documentation.

The most complete record groups are the Departments, Positions, and Post Office series. These series contain correspondence, clippings, and notes relating to individual casework files. Constituent correspondence with various government departments requesting assistance, information concerning local and federal post offices, and requests for positions in the government constitute most of the three record groups. The papers are nearly complete for 1951-73. The Post Office series is arranged alphabetically by the name of the town; the Departments and Positions series are arranged alphabetically by the correspondent's name.

The General series contains correspondence, reference material, and related papers on various subjects in which Arends or his constituents were interested. Similar material also can be found in the Departments series. The General file is arranged alphabetically by correspondent or subject. There is little documentation in the General series for years other than 1960-62 and 1970-73.

The Legislation series is divided into three subdivisions: bills, committees, and voting records. The largest, committees, consists primarily of constituent correspondence relating to a broad range of subjects considered by various House committees. Bulk dates are 1970-71 and 1973-74; the sub-series is arranged by name of the committee.

Another significant series is Speeches, 1947-74. It is nearly complete and is arranged chronologically by date of the speech. There are no speeches for 1971.

The remaining series are smaller and coverage less complete. The Publications series contains congressional directories and Arends' weekly newsletter, "Inside News of Congress," dating from 1935-74. The White House Press Releases series dates from 1971-74 and includes chronologically

arranged press releases concerning the Richard M. Nixon and Gerald R. Ford administrations. Other series described in the finding aid are audiovisual, 1953-75, and photographs, 1930-74.

Despite Arends' thirty-one years as Republican assistant floor leader, few documents exist to record his activities. Constituent correspondence comprises most of the collection and many of Arends' responses appear to have been form letters. With some exceptions, notably the speech series and Armed Services committee file, there are few working papers that document the development of Arends' positions on issues. Some reference to position stands can be found in the Speeches and Legislation series.

The Departments series consists primarily of correspondence and requests for assistance, information, or intervention concerning a variety of subjects. Correspondence concerning the military constitutes a substantial part of the series. Other subjects frequently mentioned are pensions, welfare, social security, veterans' benefits, and unemployment compensation. Requests for assistance in obtaining visas or government contracts and complaints about foreign policy and federal spending are numerous.

The series is arranged alphabetically by name of correspondent and chronologically within individual case files. Occasionally the Arends office filed correspondence alphabetically by name of an individual intervening on behalf of an acquaintance. In these cases the original order has been preserved. The series includes some subject files which are arranged alphabetically and chronologically within each file. Examples are Agriculture Department, Armed Services, Danville, Danville Junior College, Mackinaw Dam, Requests, and Visas. Alphabetical divisions in the series and each subject file are listed in the series shelf list.

The General File consists of correspondence with constituents and colleagues, notes, clippings, pamphlets, and reference material concerning many subjects including the following: public issues, legislation, politics, constituent service, and personal information. In most cases subject coverage is incomplete and fragmented. There is very little documentation for years other than 1960-62 and 1970-73. Although the General File was maintained as a distinct record series, much of the material resembles that found in other subdivisions of the Arends collection.

Some of the subject files contain documents from Charlotte Reid's congressional office, apparently as a result of her assistant, Joseph H. Macauley, joining the Arends staff upon Reid's retirement.

The General File is arranged alphabetically by correspondent's name or by topic. A shelf list describes folder contents in more detail.

The Bills section, f. 2813-2843, contains copies of bills introduced or co-sponsored by Arends on many subjects including the military, agriculture, domestic programs, the budget, campaign reforms, and others. It also includes requests by members of Congress to co-sponsor legislation and small amounts of correspondence. Related material exists in the "Arends" division of the General File.

The Committees sub-series, f. 2844-3441, comprises the bulk of the Legislation series. It is arranged alphabetically by name of committee and chronologically within each committee unit. Consisting largely of constituent correspondence, the information relates to the broad range of subjects considered by committees. In addition to letters from constituents, there are smaller amounts of colleague and departmental correspondence, memoranda, and reference materials. Major committee files include Agriculture, Armed Services, Education and Labor, Interstate and Foreign Commerce, Judiciary, and Ways and Means. The Judiciary Committee section, for example, contains a large amount of correspondence concerning the possible impeachment of Richard M. Nixon.

Generally the Committee sub-series is incomplete and fragmented. Little material exists outside of 1970-71 and 1973-74. Most of Arends's responses to inquiries appear to have been form-letter responses. With some exceptions, most notable Armed Services, there are few working papers that document the development of Arends's positions on these subjects.

The Voting Records, f. 3442-3478, consist of Arends's individual roll call records. They are arranged chronologically and are complete for his years of service.

The Post Office series consists of four sub-divisions: Communities file, 1951-73; Counties file, 1953-60; Information file, 1953-72; and Non-District file, 1952-65.

The communities file, f. 3821-4309, contains information about postal matters within Illinois's 17th congressional district. The most extensive subdivision of the Post Office series, it contains correspondence from constituents and Republican Party officials about patronage and rural mail delivery, dating largely from 1951 through 1963. Other, lesser topics include location of mailboxes, maintenance and erection of post offices, working conditions in post offices, and post office closings. Included are notes, memoranda, and summaries written by William R. Pitts, administrative assistant, for Arends's use. The file is arranged alphabetically by town name and chronologically within each town unit.

The Counties files, f. 4310-4313, consists of summaries of postal positions and status reports on applications. The file is arranged alphabetically by county.

The Information file, f. 4314-4324, contains pamphlets, press releases, and correspondence concerning the Post Office and is arranged chronologically.

The Non-District file, f. 4325-4327, consists of correspondence concerning postal positions outside the district and is arranged chronologically.

In general, the quantity and quality of files vary considerably. Some files contain only a few documents while others are lengthy. A shelf list describes folder contents in each of the four divisions in greater detail.

The Speeches file consists of outlines, drafts of remarks, notes, testimonials, eulogies, speeches, and reference material and correspondence. Arends's remarks deal with a wide range of topics. The following subjects receive relatively substantial coverage: Republican Party principles and programs; Congress; evaluation of presidential administrations; the state of the union; defense policy; and campaign issues.

In many cases, the Arends office filed correspondence and brief reference materials with copies of speeches, and this arrangement has been preserved. In addition, f. 4912-4952 contain a separate file of pamphlets, government documents, and speeches by others used for reference.

The Speeches file is arranged chronologically by the date of the speech. There are no speeches for 1971. A shelf list describes folder contents in more detail and gives specific information about major speech topics. The shelf list does not name each speech or topic.
